Motions:

A motion made that Associate Members who no longer have boats but who want to continue to be a part of CMA with no vote would pay \$10 Associate Members dues. Proposal dues: \$50 Initial entry + 1x \$25 burgee; \$25 Annual dues; \$10 Associate Member dues. Motion was not passed.

A motion to maintain the current burgee colors was made and passed.

A motion to continue the practice of stocking 10 burgees and replenishing as needed was made and passed.

A motion to provide the officers with the burgee of their respective offices. The burgees would be transferred to the succeeding officers. A motion made and passed.

A motion to include the duties of Membership Officer with the Rear Commodore's responsibilities was made and passed.

A motion to establish a welcome packet for new members - burgee, roster, etc. was made and passed.
